## FREQUENTLY ASKED QUESTIONS

### What is Severn Run Umbrella?

Severn Run Umbrella is a community ministry of Severn Run Evangelical Presbyterian Church and is registered to supervise home instruction by the Maryland State Department of Education. Our program operates in compliance with the Code of Maryland Regulations (COMAR) 13A.10.01 and is designed for responsible families who understand that they are legally and morally responsible to educate their children in accordance with these standards. The focus of our Home School Umbrella is to support parents in preparing their children with a sound, Biblically based worldview that is founded on a solid education.

## • What services do you provide?

In addition to legal oversight, we also provide mentoring for our members, free membership for each family in the Maryland Association of Christian Home Educators (MACHE) and a 15% discount for Home School Legal Defense Association membership.

## What does Maryland homeschool law require?

Maryland homeschool law requires that parents provide regular, thorough instruction in English, mathematics, science, social studies, health, art, music, and physical education. http://www.dsd.state.md.us/comar/comarhtml/13a/13a.10.01.01.htm

# • What documentation is required of its members by the umbrella in order to demonstrate compliance with Maryland homeschool law?

The documentation provided by the parent must include sufficient samples of each student's work in each subject to show evidence that the instruction listed on the Textbook/Lesson Materials form did, in fact, occur.

### What type of review system do you offer?

We offer a reviewer mentoring system. Each member will be given an experienced reviewer/mentor to support, guide, and encourage them in their homeschooling efforts throughout the year. Reviewers will also conduct a midyear telephone review and a final review in person at Severn Run Evangelical Presbyterian Church. Each member family will be given contact information for their reviewer in the fall. Please feel free to contact your reviewer at any time during the school year if you have any questions or concerns.

# • Do you offer homeschool umbrella diplomas?

No. Although parent issued documents and diplomas are accepted by the state as legitimate proof of education for employment, recent legal issues in Maryland have made it clear that homeschool umbrella issued documents are not.

## Do you offer a transcript service?

No. Transcripts are typically created and signed by parents. We will be happy to advise and assist members in creating their own transcripts and diplomas. Your reviewer is available to support you if you need guidance in this area. In addition, Home School Legal Defense provides an extensive amount of information to guide parents in

# • Do I need to be a member of Severn Run Evangelical Presbyterian Church in order to join Severn Run Umbrella?
